**Pensioner's Returning
to Covered Employment**

If you are younger than age 71 and return to Covered Employment, you may choose one of the following two options:

OPTION 1

Suspension of monthly pension benefits and, upon subsequent retirement, you will be entitled to a recalculation of your pension amount. Please note, you may not suspend your pension benefit if you are currently working in Covered Employment (i.e. you must not have hours reported to the plan on the date written notice is received by the plan administrator).

NOTE: If you return to Covered Employment and elect OPTION 1, once you chose to reinstate benefits, you will not be permitted to choose OPTION 1 again in the future. Therefore, consider carefully the decision to suspend benefits.

OPTION 2

Continuation of monthly pension benefits in the amount payable before your return to Covered Employment.

NOTE: You will not be entitled to a recalculation of your pension amount or any other credit or benefit for contributions remitted on your behalf after your return to Covered Employment.

I understand I may elect one of the above options and that should I elect OPTION 1, the suspension and further benefit accrual will become effective with the month following the date written notice is received by the Administrator.

You will be entitled to a recalculation of your pension amount, which will be calculated from the effective date of the suspension until the effective date of the reinstatement.

NOTE: If you elect OPTION 1: *Suspension of monthly pension benefits*, once you choose to reinstate benefits, you will not be permitted to choose OPTION 1 again in the future. Therefore, consider carefully the decision to reinstate benefits following a suspension.
